EXTENDED DAY PROGRAMS

We are unable to offer these programs to children with special needs requiring additional support. Children must be in the 3, 4, or 5-day classes to enroll. The following choices will be available:

AM & PM LUNCH

AM CLASSES -- Monday through Friday, 11:30 to 1:30; PM CLASSES -- Monday through Thursday, 11:30 to 12:30.

PM AFTER SCHOOL CARE

Monday through Thursday, 3:00 to 4:30 for families needing a longer day. **(Dependent upon minimum enrollment)**

TUITION AGREEMENT

For 2-5 day classes: I am enclosing a \$100 registration fee which is nonrefundable if my child is offered a class placement.

For Parent/Child Class: I am enclosing a \$50 registration fee which is nonrefundable if my child is offered a class placement.

For Clase de Padres e Hijos: I am enclosing a \$25 payment which is nonrefundable if my child is offered a class placement.

PARENTAL PARTICIPATION AGREEMENT

Warren W. Cherry Preschool is an independent, parent-governed, not-for-profit, non-sectarian preschool open to all children in our community. The school admits students of any race, color and national or ethnic origin, and does not discriminate in the administration of its educational policies, admission policies, financial aid program, or other school administered programs. Cherry Preschool exists without the sponsorship of a larger institution, thus enjoying independence, stability, and the benefits of being able to focus all its energies on innovative, developmentally appropriate early childhood educational programs. To provide our children with enriching activities, compensate our staff fairly, and include children with special needs and children who are economically disadvantaged, families are required to volunteer their time and energy in support of the school.
